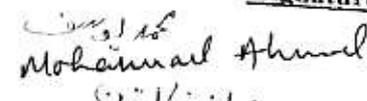
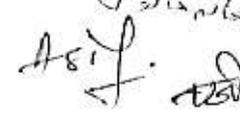

One can apply for the membership in the prescribed form along with the application fee Rs. 500/- and annual subscription of Rs. 500/- only. they have one vote right.

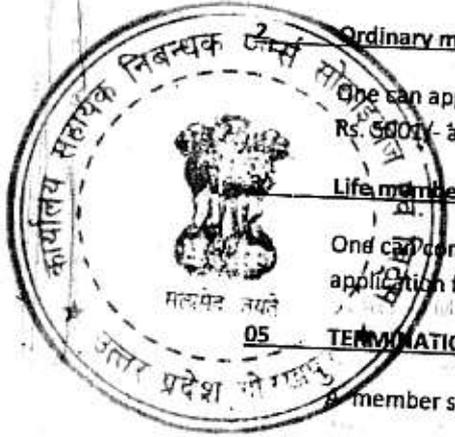
Life member

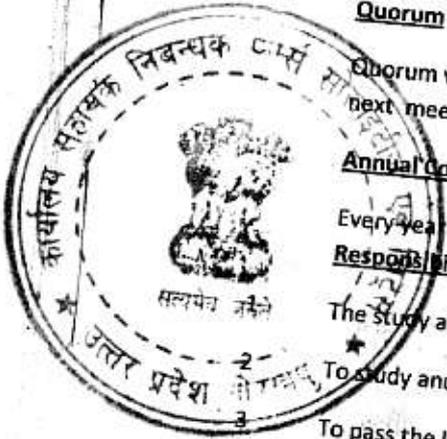

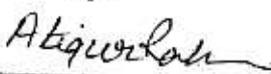

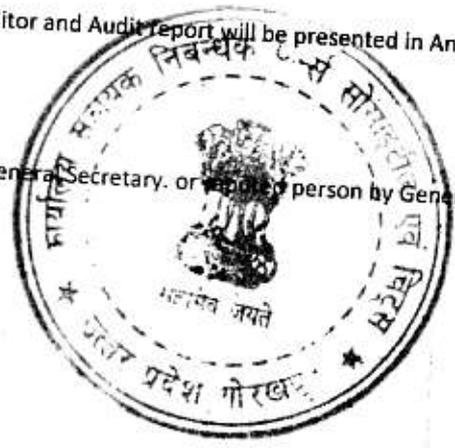
